



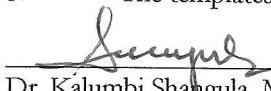

PUBLIC NOTICE

No. 7/2021

AUTHORITY TO ACT AS AN AUTHORISED PERSON IN TERMS OF THE PUBLIC AND ENVIRONMENTAL HEALTH ACT, 2015 (ACT No. 1 OF 2015)

1. I, in my capacity as the Minister of Health and Social Services, authorize the following persons to act as authorized persons in terms of section 30(2)(b) of the Public and Environmental Health Act, 2015 ("the Act"), read with the Public Health Covid-19 General Regulations: Public and Environmental Health Act, 2015 ("the Regulations") for the period of 17 June to 30 June 2021, with respect to the Local Authority Areas in which such persons operate:
 - 1.1 Police Officer (Station Commander) or higher rank, or as designated by Inspector General of the Namibian Police,
 - 1.2 Executive Director or Regional Director of Health and Social Services,
 - 1.3 Executive Director or Regional Director of Education, Arts and Culture,
 - 1.4 Executive Director or relevant Director in the Ministry of Industrialization and Trade, and
 - 1.5 Executive Director or relevant Director in the Ministry of Environment, Tourism and Forestry.
2. An authorized person is required to issue a permit to any person who wishes to enter or depart a local authority area (described as a restricted area) in terms of regulation 2B of the Regulation in the following circumstances as specified in regulation 5A (1) of the Regulations:
 - 2.1 a resident of the local authority area and who wishes to return to this area from any place;
 - 2.2 a resident of an area outside the local authority area, who wishes to exit this local authority to that area and return to his/her place of residence in that area;
 - 2.3 a person entering or departing from the local authority area for the purpose of rendering a critical service or providing essential goods;
 - 2.4 a person entering into or exiting the local authority area for the purpose of receiving essential medical treatment;
 - 2.5 a person entering into or exiting the local authority area for the purpose of attending a funeral of a close family member or a dependant;
 - 2.6 a person entering into or exiting the local authority area for the purpose of transporting human remains;
 - 2.7 a person entering into or exiting the local authority area for the purpose of assisting a close family member or dependant who is ill or otherwise suffers from a distressing situation;
 - 2.8 an international tourist interring for tourism purposes and the person has presented a negative SARS-CoV-2 test result on entry into Namibia; or
 - 2.9 any other emergency situation which, in your view, is considered sufficient to warrant the interring or departing the local authority area.
3. An authorized is permitted to issue a permit, after consideration of the relevant information, for the full duration of the specified period (17 June to 30 June 2021) in the instance of paragraphs 2.3, 2.4 and 2.9 above. In the instance of paragraph 2.8, you may issue a permit to a tourist at the entry and departure points of the local authority area. For any other instance, you are permitted to issue a permit, after consideration of relevant information for the duration of such entry and departure.
4. Kindly ensure that the performances of your duties in this respect are carried out with the required skill, diligence and fairness; and reasonably, without causing any undue hardship to those that seek the permit, but importantly, with the intention to curb the spread of Covid-19.
5. The templates of the Permits that may be issued during the period of such authority as an authorized office.
